### Ocean Research Advisory Panel

Congress directed the establishment of the ORAP in Section 1055(c) of the William M. (Mac) Thornberry National Defense Authorization Act for Fiscal Year 2021

#### **ORAP's responsibilities are:**

- to advise the OPC on policies and procedures to implement the National Oceanographic Partnership Program;
- 2. to advise the OPC on matters relating to national oceanographic science, engineering, facilities, or resource requirements;
- 3. to advise the OPC on improving diversity, equity, and inclusion in the ocean sciences and related fields;
- 4. to advise the OPC on national ocean research priorities; and
- 5. any additional responsibilities that the OPC considers appropriate.

Charter approved in May 2022; Membership appointed in August 2023

ORAP management falls under the National Oceanic and Atmospheric Administration (NOAA).

### **Ocean Policy Committee**

Congress established the Ocean Policy Committee (OPC) in 2021 for the Biden Administration, through the National Defense Authorization Act, to coordinate federal actions on ocean-related matters

Every President since George W. Bush has relied on a body to coordinate ocean policy across the agencies

#### The OPC is directed to:

- Engage and collaborate with the ocean community on ocean-related matters,
- Facilitate coordination and integration of Federal activities in ocean and coastal waters to inform ocean policy,
- Identify priority ocean science and technology needs, and to
- Leverage resources and expertise to maximize the effectiveness of Federal investments in ocean research





### **ORAP Tasking (Dec 2023 Public Meeting)**

Emerging industries in the ocean economy – the Ocean Policy Committee respectfully requests that the ORAP advise on areas of opportunity for partnership (such as through the National Oceanic Partnership Program) on the topic of emerging technology (which could include Artificial Intelligence/Machine Learning, eDNA, and similar technology) with ocean industry and other sectors over the next 5-10 years.

### **ORAP Approach**

Develop a landscape assessment and horizon scan of current and emerging technologies for ocean biogeochemical sensing (e.g., eDNA, microfluidics, optofluidics, lab-on-a-chip) including:


- Current and potential technology applications;
- Technology, market, and industry maturity level;
- Key innovators, manufacturers, adopters;
- Current partnerships and potential partnership opportunities to support market growth and technology adoption, and
- Existing technology and/or industry and market gaps, regulatory inefficiencies, and barriers to success.

### **ORAP Self Selected Topic: Data Management**

Develop a landscape assessment and horizon scan of current ocean data management programs, priorities, and services in the United States including:

- Current federal and non-federal ocean data management programs
- Key federal data centers and repositories
- Existing partnerships and opportunities to leverage, expand, and consolidate data services through new partnerships.
- Regulatory, economic, programmatic, and technical barriers to progress.
- Key identified hurdles and challenges
- Key identified potential solutions and recommendations for discussion
- Define "What is success" for this effort?

### **ORAP History**

The Ocean Research Advisory Panel (ORAP) is a federal advisory committee (FAC) as defined under the Federal Advisory Committee Act (FACA).

ORAP is a non-discretionary FAC\* with representative members and provides the Ocean Policy Committee (OPC) with independent scientific advice and recommendations on national ocean matters.

The ORAP was originally chartered under the Office of Naval Research (ONR), which awarded management to the Consortium for Ocean Leadership.

From 2006-2011, the ORAP operated as the Ocean Research and Resources Advisory Panel (ORRAP). The Panel returned to the name ORAP in 2011.

ONR managed NOPP and ORAP until the passage of the William M. (Mac) Thornberry National Defense Authorization Act for Fiscal Year 2021 (P.L. 116-283), which reauthorized NOPP and moved management responsibility for ORAP to NOAA.
